
Dear Clerk of Court,

I would like to take the time to thank you and your office in advance for any and all assistance that may be provided in helping with this matter...

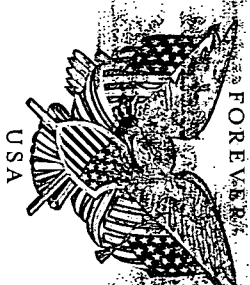

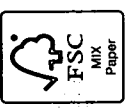
