REQUEST FOR TRANSCRIPT OF THE RECORD


TO: THE HONORABLE CHIEF JUSTICE AND ASSOCIATE JUSTICES OF THE SOUTH





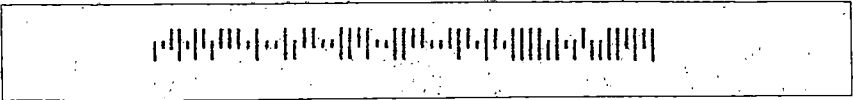
