
Appellant John English would respectfully request that the instant matter be reinstated. Appellant recognizes that he has not prepared and filed the Record on Appeal. With respect, Appellant would submit that the procedural history of this matter is sufficiently convoluted that he was unaware that the action was fully ripe for the final stages of the appeal.

Appellant filed his Initial Brief on April 22, 2015. Respondent Ellen Sexton filed an Initial Brief on May 27, 2015. In the interim, on May 21, 2015, John White, trial counsel for Appellant, filed a separate Initial Brief. On June 10, 2015, in response to correspondence from the Clerk of this Court, Mr. White filed a Motion seeking to be relieved as counsel for Appellant and to proceed as an additional named Respondent in the action.

Given the timing of the foregoing, Appellant remained unclear as to whether Mr. White's Initial Brief – filed by a non-party at a time when the filer was still, technically, Appellant's own attorney – had or had not been accepted by the Court. Appellant did not, therefore, proceed with his further duties under the Rules of Appellate Procedure.

At this time, Appellant would respectfully ask that this Appeal be reinstated. Appellant can and will file the Record within a week of receipt of an Order reinstating the matter.





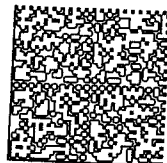
