Petitioners, Dataw Island Owners Association and Beaufort Waterman Association To Enhance Rivers, request that the deadline for filing the initial brief be extended for thirty (30) days to January 6, 2016. Enclosed please find my filing fee.

The reason for this request is that the Plaintiffs, Jenkins Creek Marine and Charters, LLC and Millenarian Trading Co., Inc., have filed a voluntary motion to dismiss in the underlying case which would render our interlocutory appeal before this court moot. 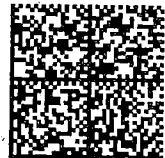
