- (2) Because of my poverty I am unable to pay the costs of said proceedings or give security thereof.

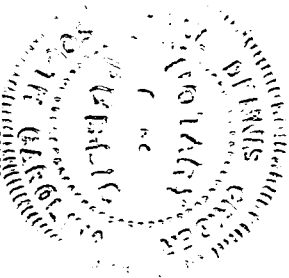
