

Dear Ms. Kitchings, Mr. Shearouse and Ms. Allan:

During the Master in Equity Hearing on 23 September, held by Master in Equity S. Jackson Kimball, III. A court reporter was not present. Researching procedures to "Appeal the judgement, I initially followed the wrong procedures in appealing this case. 

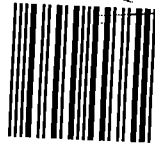
