
Pro se petitioner does not have access to online legal research and depends on Trident Technical College Paralegal Law Library for legal research. The law library is

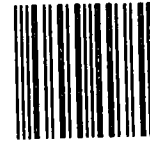
