Re: Julia Fludd V. Angela Dingle Appellate case No. 2015-002021

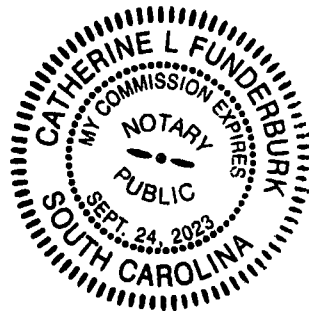
