I HAVE HEARD THIS VOICE MANY TIMES in my life and I always obey. I'm sure you have heard it to. Not always but sometimes you will come to a crossroad in the road, or in life and you will think many times about witch road should I take. Hoping for the best results you will make the decision but afterwards you will pray lord I hope my decision was right. There was a reason for that. Why you don't know but it was real. And I'm sure very important.

The voice is real if people would only listen. It has kept me going all this time and throughout my life. I have given up many times, but always at the last minute that little voice causes me to continue. As in this case my time period was up for filing the appeal, I was in a panic it was 4:45 P.M. on Friday just before the clerk was to close, and the time was up on Saturday. I did not think about It, I still had

till Monday. Being seriously depressed the brain will wait till the last moment or last minute before acting. This is the reason all correspondence with you has been at the last minute.

I am late for doctor appointments, sometimes I am too late to pickup prescription and they have been put back in stock. I do everything at the last minute Pryor to this message any very small negative thing would send me into a tailspin, which will not go away easily, and this makes me feel like I am losing it. All I do is sleep. I had rather just stay home this way I don't have to put up with what is out there.



To worry is a waste of our time and I know this, but I still do. I believe GOD will take care of it. But I cannot help worrying at times.

This is when we faultier in our faith, my how weak we really are. SATURDAY after not going out for eight days I decided to go downtown and check the mail and get some groceries I went to the Post Office to check the mail and oh my, I was overjoyed at what was in the box so I am sending it to you. (SHAME ON YOU). YOU HAVE HAD MY MONEY IN YOUR BANK SINCE JUNE 9TH 2015 .ALL THIS TIME. And all this pain I have suffered, words cannot describe. My brain is burnt out from worrying and thinking about this. Had you only ask someone to check the deposits slips for the month of JUNE 2015

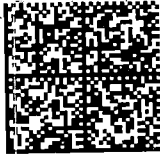

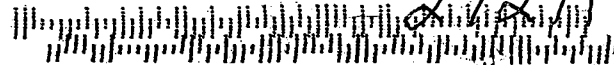
