

- The required filing fee has not been submitted. The correct filing fee is \$25.00.

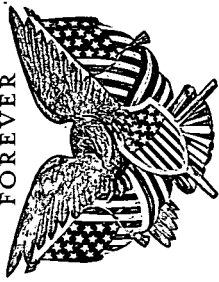

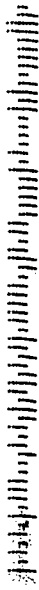
