1 MS. COOK: I guess so.

2 THE COURT: What do you want to tell me,  
3 Ms. Goldberg?

4 MS. GOLDBERG: Thank you, Your Honor. Quite  
5 simply, Ms. Grant absconded, it was related to a  
6 drug problem. She has a severe drug problem. She  
7 knew that if she went in to probation she would be  
8 likely tested and likely fail. And she was  
9 embarrassed and afraid and did not go and report.

10 THE COURT: She could have gone the next  
11 month.

12 MS. GOLDBERG: Well, she was not -- I don't  
13 believe she was sober for any --

14 THE COURT: She kept violating.

15 MS. GOLDBERG: -- sufficient length of time to  
16 where she could report.

17 THE COURT: Does this lady have a record?

18 MS. COOK: Yes, sir, Your Honor. And since  
19 she absconded, Your Honor, she does have other  
20 pending charges.

21 THE COURT: Oh, my goodness.

22 MS. COOK: Her record is rather lengthy.

23 THE COURT: Are you appointed on this?

24 MS. GOLDBERG: I am.

25 THE COURT: All right.

1 MS. COOK: It dates back to 1997.

2 THE COURT: Is there anything you want to tell  
3 me?

4 THE DEFENDANT: Sir, I just wanted to  
5 apologize to Ms. Cook and to the probation people.

6 THE COURT: How long have you been in jail?

7 THE DEFENDANT: I've been in jail for 30 days.

8 MS. GOLDBERG: Well, Your Honor, I'd like to  
9 speak to the amount of time.

10 As you can see on the violation report, when  
11 she was originally sentenced they gave her credit  
12 for 133 days which she served before the plea,  
13 which was appropriate.

14 She was served with a probation violation  
15 warrant June 30th. She got out July 29th. That is  
16 an additional 24 days.

17 She got out. Got a bench warrant. Since she  
18 has been in 22 days. So that is an additional 46  
19 days she is entitled to.

20 THE COURT: All right.

21 MS. GOLDBERG: But there is one other thing,  
22 Your Honor. While her charges were pending, before  
23 she pled guilty and got the probation violation,  
24 she was incarcerated in DeKalb County, Georgia. I  
25 have confirmed that she had a hold placed on her

1 for 365 days. She was extradited to South  
2 Carolina. I believe the case law states that she  
3 would be entitled to that additional one year of  
4 credit.

5 I've got a case here, if you would like me to  
6 hand it up. It is Blakney v. State. It relates to  
7 a hold being placed in a different county. It  
8 doesn't say anything about a different state. I  
9 would say it is analogous.

10 So I would ask that all of that time count  
11 towards this offense.

12 THE COURT: She was out on bond when she was  
13 -- what do the charges in Georgia have to do with  
14 probation?

15 MS. GOLDBERG: Only the fact that she -- there  
16 was a -- let me give you the timeline.

17 THE COURT: There was a hold on her?

18 MS. GOLDBERG: There was a hold on her for the  
19 warrant, breach of trust with fraudulent intent,  
20 which is one of the warrants that she was placed on  
21 probation for.

22 THE COURT: That was before she pled guilty?

23 MS. GOLDBERG: Yes. Yes.

24 THE COURT: All right. All right, I am going  
25 to find she violated. The violations were willful.

1 I am going to revoke four years and give her credit  
2 for -- how much did you say, 100 and some-odd?

3 MS. COOK: She previously had 133 days.

4 THE COURT: But Ms. Goldberg has added up a  
5 bunch of other numbers.

6 MS. GOLDBERG: She has served a total 179 days  
7 in the Kershaw County Jail for these charges. If  
8 you --

9 THE COURT: I will give her credit for 179  
10 days.

11 MS. COOK: Thank you, Your Honor.

12 MS. GOLDBERG: Thank you, Your Honor.

13 THE COURT: She will be out before she knows  
14 it.

Annetta Grant

1. I shall report in person to the South Carolina Department of Probation, Parole and Pardon Services' office on the day of my sentencing or release, and as instructed by the Department; and I shall make complete and truthful reports to the Agent.
2. I shall not change my residence or employment without the consent of my Agent. Further, I shall allow my Agent to visit me in my home, at my place of employment, or elsewhere, at any time.
3. I shall not use controlled substances, except when properly prescribed by a licensed physician, nor consume alcoholic beverages to excess, nor enter establishments whose primary business is the sale and drinking of alcoholic beverages. Further, I shall submit to a urinalysis, blood test or provide forensic evidence when instructed by Agents of the Department, and I agree that any of these test results may be used as evidence in any hearing for the violation of the conditions of my supervision.
4. I shall not possess or purchase any firearms or other dangerous weapons, and I shall not associate with any person who has a criminal record, or any other person whom my Agent has instructed me to avoid.
5. I shall work diligently at a lawful occupation. Further, I shall notify my Agent if I become unemployed.
6. I shall not violate any Federal, State, or Local Law, and I shall immediately contact my Agent if I am ever arrested or questioned by a law enforcement official for any reason whatsoever.
7. I shall pay a supervision fee and any other fees as determined by the Department.
8. I shall not leave the State without permission from my Agent. Further, if I am ever arrested in another state for violating these conditions, I hereby irrevocably waive all extradition rights I may otherwise have been entitled to and agree to return to South Carolina when directed by my Agent, the Court or by a warrant.
9. I shall obey all conditions of supervision set forth in this order including the payment of fines, restitution or other payments, and the service of any period of incarceration.
10. I shall follow the advice and instructions of my Agent and I agree to comply with any further conditions imposed by the Department or its Agents.
11. I agree to pay restitution and a statutory collection fee payable to the Department of Probation, Parole, and Pardon Services as directed by Agents of the Department. (20% collection fee charged)
12. Unless I was convicted of or pled guilty or nolo contendere to a Class C misdemeanor or an unclassified misdemeanor that carries a term of imprisonment of not more than one year, I shall be subject to a search or seizure, without a search warrant, based on reasonable suspicions, of my person, any vehicle I own or am driving, and any of my possessions by: (1) any probation agent employed by the Department; or (2) any other law enforcement officer.

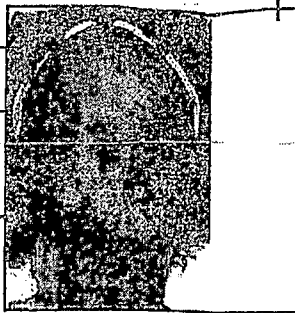


