
TO: Circuit Court

Now comes the Tenant, Edna Price, in the above entitled action and respectfully shows the Court that a Judgment of Execution was issued against Edna Price and for the Landlord, Josh Blackwell on September 15, 2015, by the Magistrate, Josef M. Robinson. Edna Price has appealed the Judgment to the Circuit Court.


