**MOTION TO REDACT RECORD ON APPEAL**



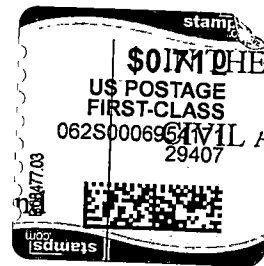
