
1. The petition for writ of certiorari and appendix in this case are due to be served and filed today, having been extended by two prior orders of this Court.
2. Counsel filed the petition for writ of certiorari and accompanying appendix and the brief of appellant pursuant to White v. State in the case of Robert S.


Horton v. State in this Court on January 8, 2016. Counsel filed the petition for an order to reconstruct the record of appellant's trial transcript, or, in the alternative, an order setting aside his convictions and ordering a new trial in the case of State v. Ivory Blackshire in the Court of Appeals on January 4, 2016. Counsel filed the Anders brief of Appellant and Record on Appeal in the case of State v. Roemain Jamil Brunson in the Court of Appeals on December 30, 2015. Counsel filed a petition for writ of certiorari and accompanying appendix in the case of Nicholas Nesmith v. State in this Court on December 16, 2015. Counsel filed a petition for writ of certiorari and accompanying appendix in the case of Keith O. Williams v. State in this Court on December 7, 2015. Counsel argued in the case of State v. Alexander L. Hunsberger in this Court on December 2, 2015. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Antonio Jordan in the Court of Appeals on November 24, 2015. Counsel filed a petition for writ of certiorari to the Court of Appeals in the case of State v. Leonard Eugene Jenkins in this Court on November 18, 2015. Counsel filed a petition for writ of certiorari and accompanying appendix in the case of Claude Dunagin v. State in this Court on November 16, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Shane Adam Burdette in the Court of Appeals on November 12, 2015. Counsel filed the initial brief of respondent and designation of matter in the case of State v. Marvin Brown in the Court of Appeals on November 12, 2015.

3. This request is made in good faith, and not for purposes of delay.
4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.

WHEREFORE, the undersigned counsel would respectfully request a **final** thirty-day extension, until **February 12, 2016** in which to file the petition for writ of certiorari and appendix in this case. Counsel requests that the time limits for filing the petition for writ of certiorari be held in abeyance pending a ruling on this motion.
