Appellant, Diana Jordan hereby moves for an extension of time in this appeal until SCDEW responds to the 11/25/15 timely submission of evidence exonerating Appellant of fraud and overpayment.

STATEMENT OF FACTS FOR PURPOSE OF THE MOTION

- 1) The SCDEW had an order releasing tax information for the July 2014 hearing but chose not to include Appellant's W2's.
- 2) On 10/1/15 a notice of action regarding federal income tax returns was sent to Appellant.
- 3) On 11/25/15 Diana Jordan timely submitted W2's for 2012, 2011, 2008, 2007, 2005 and Social Security record with contributions back to 2002 visible, to BPCollections@dew.sc.gov.
- 4) The amounts reported to the Internal Revenue Service and Social Security are exactly the same as what was reported to SCDEW and exonerate Diana Jordan of fraud and overpayment.
- 5) The South Carolina Court of Appeals ORDER dated 11/7/16 provides proof that the appeal has not concluded therefore the SCDEW must reverse their assessment of fraud and overpayment.

CONCLUSION

After weighing the appropriate factors, this Court should conclude that Diana Jordan has shown support for an extension of time and grant the motion. SCDEW will need

to reverse their assessment of fraud and overpayment based on the 11/25/15 timely submission of evidence which will negate the need to continue this appeal at all.

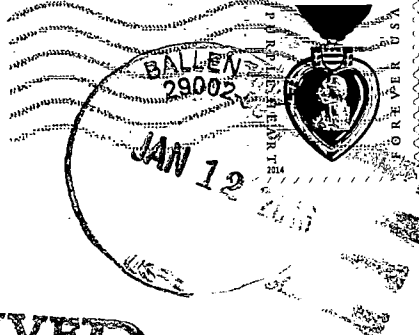
