
- 1.)... I am the appellant in the above action and I believe in "GOOD-FAITH" I am entitled to redress in this matter; and,



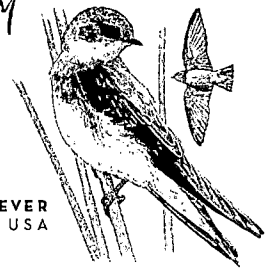
