3) The Order, entered by the Honorable Paul M. Burch, dated August 18, 2014, to the extent it ordered rulings adverse to either of the Appellants;


4) The Order, entered by the Honorable Paul M. Burch, dated January 25, 2015, to the extent it ordered rulings adverse to either of the Appellants; and


