


Dear Ms. Hanks:

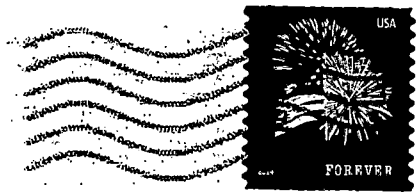
