OF TIME


I, Dameon Myers, now timely petitions the court in the above matter pursuant for an extension of time to file my Writ of Certiorari. I will show the following:

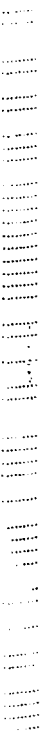
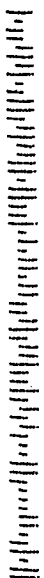
