
**THE CITY OF COLUMBIA'S MOTION



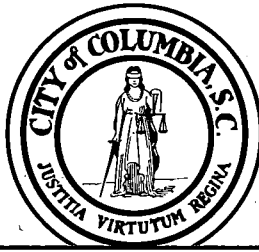
