Dear Ms. Kitchings:

This case was remanded last fall by the Supreme Court to The Court of Appeals. I received the Appellant's Initial Brief on Christmas Eve. My oldest son was born with a serious congenital heart defect. He has had multiple heart surgeries, has a pace maker and, also, has significant psychiatric issues. Since around Thanksgiving, he has been experiencing heart failure and has been in and out of the hospital in Georgetown and MUSC. We recently took him to Duke for a second opinion. We are now awaiting word from Duke about returning there for a procedure, which hopefully will alleviate the heart failure. As you might well imagine, this has been very distracting and time consuming. Additionally, we have had the customary avalanche of work that accompanies the new year.

To this end, I am respectfully requesting a 30-day extension to file the Initial Brief of William George. I anticipate filing the brief long before the end of the extension but need additional time in order to adequately represent my client.

Please find enclosed my firm's check in the amount of \$25.00 for the filing fee for this request.


I received an extension or two during the initial appeal, but I have not requested any since the case was remanded.
