personally with the court.

I'm in receipt of documentation from you  
dated January 06, 2016. In this correspondence it seems  
that you are trying to tell me that my convictions have been  
upheld by the Supreme Court on Writ of Certiorari to the  
Court of Appeals. However I'm not sure if this fraudu-

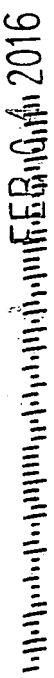

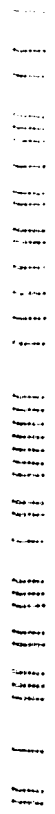
