FROM ANY COURT IN SOUTH CAROLINA.

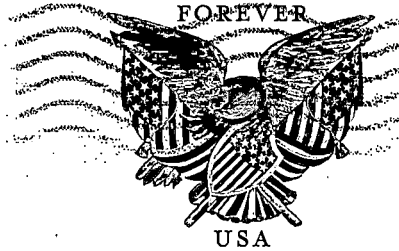

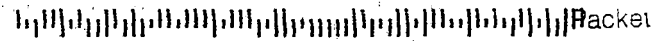
