2 THE COURT: All right. We are here in the matter of  
3 the State vs. Prince Deven Snipes.

4 Mr. Snipes has been indicted in case No.  
5 2012-GS-11-608, an indictment for murder and possession of  
6 a firearm during the commission of a violent crime.

7 These are Cherokee County -- is a Cherokee County  
8 indictment.

9 Mr. Campbell, you represent the defendant?

10 MR. CAMPBELL: That's correct, Your Honor.

11 THE COURT: Solicitor Barnette is here on behalf of  
12 the state.

13 The purpose of this hearing today is for the taking  
14 and preservation of testimony of two persons the state  
15 contends are eye witnesses to the event in question, and  
16 the purpose of the videotaping and preservation of the  
17 testimony is to preserve it in the event that one or both  
18 of those witnesses is unavailable to testify in person at  
19 the time that the case is called for trial.

20 Mr. Campbell, you and your client are in agreement  
21 with the videotaping of this testimony?

22 MR. CAMPBELL: Yes, Your Honor. We consented to this  
23 by via consent order, Your Honor.

24 THE COURT: That's true, Mr. Snipes?

25 THE DEFENDANT: Yes, sir.

1 THE COURT: And this is actually a Cherokee County  
2 case. Y'all are also in agreement for the testimony to be  
3 taken here in Spartanburg County?

4 MR. CAMPBELL: That's correct, Your Honor.

5 THE COURT: And you discussed that with Mr. Snipes?

6 MR. CAMPBELL: I have. We felt that it was in the  
7 best interest of all parties, and due to judicial  
8 efficiency, Your Honor.

9 THE COURT: All right. Thank you, sir.

10 All right. Solicitor.

11 MR. BARNETTE: Thank you, Your Honor.

12 Just to put on the record, Your Honor, Ms. Boyd and  
13 Mr. Houey both had health problems. We appreciate the  
14 Court doing this for us, as well as the defense.

15 As a matter of fact, Ms. Boyd had just come off open  
16 heart surgery from there, and she is present. She just got  
17 out of the hospital just recently about that.

18 Your Honor, I'd like to call Dorothy Boyd first, Your  
19 Honor, to testify, Your Honor.

20 DOROTHY BOYD, having been  
21 first duly sworn, testified as follows:

22 THE COURT: If you will, you can pull that chair up  
23 closer to that microphone. And please use that microphone  
24 for the purpose of providing your answers to the questions.

- 1 DIRECT EXAMINATION BY MR. BARNETTE
- 2 Q Ms. Boyd, if you would, look this way. And if you  
3 can't hear me, please let me know. Okay.
- 4 Could you give me your full name for the record,  
5 please?
- 6 A Dorothy R. Boyd.
- 7 Q And where do you live at, Ms. Boyd?
- 8 A 106 Concord Heights, Gaffney.
- 9 Q Okay. And back on December the 16th of 2010 was you  
10 in that area that day, ma'am?
- 11 A which area you talking about?
- 12 Q was you in the -- let me go back. Can you tell us  
13 what happened that day?
- 14 A well, Ms. Houey had called me the day before and asked  
15 me to come and move her stove from her mama's house to her  
16 house. Then they was going to a sister's house to pick up  
17 a table and some chairs. And she got her grandson up out  
18 of the bed to help her move them. So Rody -- we call him  
19 Rody. That was Breezy's mama. They was gone to get a key  
20 from this boyfriend of her granddaughter. And so when he  
21 come -- when she got back this tall guy, he come out of the  
22 front of that trailer.
- 23 Q Let me slow you down a little bit.  
24 who is Breezy if you can tell us?
- 25 A Rose's son.

- 1 Q And who is Rose?
- 2 A Breezy's mother.
- 3 Q Okay. And how do you know them, ma'am?
- 4 A I been knowing them all my life.
- 5 Q Okay. And they were helping move furniture that day?
- 6 A Yeah.
- 7 Q And who were they moving furniture for that day?
- 8 A Tasha.
- 9 Q And where does Tasha live?
- 10 A In that trailer park down there.
- 11 Q Okay. Where is the trailer park located, ma'am?
- 12 A It's right off of 150.
- 13 Q Okay. Is that in Cherokee County?
- 14 A Uh-huh.
- 15 Q Okay. And Ms. Houey. Do you know Ms. Houey for
- 16 years?
- 17 A Yeah.
- 18 Q And her son Breezy, do you know what his real name is?
- 19 A I ain't never knowed his real name. They always
- 20 called him Breezy.
- 21 Q So you've always known him as Breezy. But it's her
- 22 son.
- 23 A Uh-huh.
- 24 Q Okay. Going back to that day, tell us what happened.
- 25 A Well, when she picked up the table and the chairs to

1 carry down to Tasha's house, and Breezy, he had stacked the  
2 chairs real nice and neat on the side of the porch where  
3 they can get the table in there first.

4 And it was a tall guy come out from up there where  
5 Prince was living at, and so he say, "Hey, Breezy, come  
6 here." And it was foggy and rainy that morning. And he  
7 walked up there, and he went about middle ways of the  
8 trailer and had his hand on the side of the trailer.

9 Well, he hit something. He jumped and looked around  
10 like that. And Breezy -- I mean not Breezy -- Prince. He  
11 was coming out the back door with that, that semiautomatic  
12 rifle.

13 And when he got to the middle of that road it just pop,  
14 pop, pop, pop, pop, pop. And I jumped. I told her --  
15 Martha Jean -- I told her. I said, "Martha Jean, looky  
16 there." And she jumped and looked around. And I jumped  
17 outta the truck. And I told her, I said, "You ain't got to  
18 shoot that boy like that." And he didn't say a word to me.  
19 He just kept on walking and shooting him in the back.

20 And when Martha Jean got out and said something to him,  
21 he says, "He brought the mess to me. I didn't bring it to  
22 him."

23 MR. CAMPBELL: Objection, Your Honor. Hearsay.

24 THE COURT: Overruled.

25 Q Go ahead and say what -- and when you're talking about

- 1 Prince, you talking about the defendant in this case?
- 2 A The one that shot, done the shooting.
- 3 Q And do you see him in the courtroom here today, ma'am?
- 4 A No, I don't see him.
- 5 Q You don't see him?
- 6 A Because he -- he was bigger -- he's bigger than that
- 7 guy right there was, because I -- my first -- when I always
- 8 see'd him he'd be in the car riding. But as far as him
- 9 being on the ground walking, that was my first time seeing
- 10 him on the ground walking.
- 11 Q Okay. But do you know who Prince Snipes is?
- 12 A Not really, not really.
- 13 Q Do you know him by name?
- 14 A No.
- 15 Q Okay. Do you see Prince Snipes, the man that shot
- 16 Breezy, in this courtroom here today, ma'am?
- 17 A Don't look like him to me because he was bigger.
- 18 Q Well, you realize this happened back December 16th of
- 19 2010.
- 20 Okay. So you saw a man shoot him that day?
- 21 A Yeah, I saw him shoot him.
- 22 Q And how did he shoot that man, shoot the man?
- 23 A How did he shoot Breezy?
- 24 Q Yes.
- 25 A He was walking behind him, and Breezy was running, and

1 he was shooting him in the back. And then he run until he  
2 couldn't run no more, and he just stopped and turned around  
3 and looked at him. And then he just fell over backwards.  
4 And he walked about as far as from here to where you  
5 standing at and aimed that gun at his head and shot his  
6 eyeballs out.

7 Q So he went back and shot him after he shot him?

8 A Uh-huh, yeah. He never did stop. He just kept  
9 walking.

10 Q And was Breezy laying on the ground when he shot him?

11 A Yeah.

12 Q what happened after that, ma'am?

13 A He turned around and went on back up there and got in  
14 his car and left.

15 Q And what did you do after that?

16 A I went back and got in the truck, because it was kind  
17 of foggy and rainy.

18 Q Did anybody call 9-1-1?

19 A I did. I was so upset another guy, he took the phone  
20 from me and dialed it, because I was -- I was kinda  
21 hollering. And they might've couldn't understand what I  
22 was saying.

23 Q Yes, ma'am.

24 MR. BARNETTE: Let me mark as Court's Exhibit No. 1.

25 (Photograph marked Court's Exhibit No. 1.)

Direct examination by Mr. Barnette

1 Q Let me show you this picture, ma'am, Court's Exhibit  
2 No. 1. Was this the location where Breezy fell on the  
3 ground?

4 A Yeah. His foots is that way, and that's his head  
5 right there.

6 Q Okay.

7 A And I would be right below on this side of this field  
8 right there, because that don't look like my truck.

9 Q Right. I think the vehicle's been moved out of this  
10 picture.

11 A Oh, it has?

12 Q Yes, ma'am.

13 A Then that'd been Tasha's trailer. And they'd've been  
14 another trailer and that'd been where -- I ain't saying  
15 that was the trailer he -- Prince was in. But this would  
16 have been his trailer right here. And he come out that  
17 back door. And Breezy was right -- about right along  
18 middle ways of that trailer right there. He looked around  
19 when he saw that boy with that gun, and he took off running  
20 down the road right there. He got that far, and he turned  
21 around and looked at him.

22 THE COURT: Be careful of the microphone.

23 A About a split second, then he just fell over  
24 backwards.

25 Q And what -- what -- how long was the gun that Prince

1 Snipes had that day?

2 A Looked like it might've been about that long.

3 Q Okay. And how many times did he shoot it, ma'am?

4 A I really don't know because it was just pop, pop, pop,  
5 pop. I would say about eight times.

6 Q Okay. And after he shot him initially did he go back  
7 and shoot him again?

8 A He never did turn around. He just kept walking. And  
9 after Breezy fell he went and walked on up there pretty  
10 close to him and aimed the gun at his head and shot his  
11 eyeballs out.

12 Q Did Prince -- did Breezy ever have a gun or anything?

13 A No. Breezy didn't have nothing -- nothing but a  
14 cigarette in his hand.

15 Q So he had a cigarette in his hands?

16 A Uh-huh.

17 Q That's the only thing he had in his hands.

18 A That's the only thing he had in his hand.

19 Q Did he ever threaten Prince Snipes or anything like  
20 that?

21 A No. This -- this other guy, the one that called  
22 Breezy up there. Breezy was leaned up against my truck,  
23 and he said, "Hey, Breezy, come here." And so he just  
24 walked on up there and was standing there with his hand up  
25 against the trailer. And this man Breezy -- I mean, Prince

1 come out the back door; and he jumped, looked around like  
2 this. And he see'd that gun and he took off to running.

3 Q So he didn't threaten Prince Snipes in any way.

4 A Uh-uh.

5 MR. CAMPBELL: Objection, Your Honor. Speculation.

6 THE COURT: Overruled.

7 Q So did -- did Prince Snipes have any reason that you  
8 could see to shoot Breezy?

9 A Well --

10 MR. CAMPBELL: Objection, Your Honor. She stated  
11 earlier that she couldn't identify who the shooter was, and  
12 Mr. Barnette's putting words in her mouth as to who.

13 THE COURT: Sustained.

14 Q But Breezy never threatened the shooter in any way.

15 A No. They called him up there.

16 Q Did you see a lineup later afterwards or anything?

17 A Say that again.

18 Q Did you see a lineup by the sheriff's department or  
19 anything of anybody in this case?

20 A Uh-uh.

21 Q So you told them that day who shoot Breezy.

22 A Yeah. When the police come down there.

23 Q And so you told him that day.

24 A He got in his car and left.

25 Q Uh-huh.

1 A They didn't see him. He got in his car and left. He  
2 went on back up there, and he shoot that boy's brains out  
3 and -- not his brains. His eyeball out. He went on back  
4 up there and got in his car and took off.

5 Q And did you ever see him after that?

6 A Uh-uh. I still ain't see'd him up until today.

7 Q Okay. When you say he looked bigger or whatever, do  
8 you see anybody that resembles the person that shoot Breezy  
9 in this courtroom here today?

10 MR. CAMPBELL: Objection, Your Honor. He's asked her  
11 this two times already, and she's already denied that.  
12 This is cumulative.

13 THE COURT: Overruled.

14 A It was so much emotion going on, and you take about  
15 just a quick look at a person, and then this girlfriend of  
16 his'n, she was jumping up and down. Do you want me to use  
17 the words she was using?

18 Q No, ma'am. That's okay. We don't need to go into the  
19 girlfriend. Did she -- did she identify him, who he was?

20 A Uh-uh.

21 Q Okay.

22 A She was just using some words. And Breezy -- I mean  
23 not Breezy -- Prince had went up there and got in his car  
24 and I guess took off to North Carolina.

25 Q I understand. If you would, ma'am, please answer any

1 questions Mr. Campbell might have for you, ma'am. Thank  
2 you.

3 CROSS-EXAMINATION

4 BY MR. CAMPBELL

5 Q Ms. Boyd, I appreciate you coming here today. I  
6 know -- I think you just got out of the hospital a few days  
7 ago, didn't you?

8 A Sunday.

9 Q That's what I thought. I appreciate you coming here  
10 today. If at any point you feel uncomfortable or you need  
11 to take a break, you let me or Judge Cole know. Okay? And  
12 also sometimes I can be a little wordy. If at any time you  
13 don't understand a question of mine, just tell me, and I'll  
14 try to rephrase it for you. Okay?

15 A Right.

16 Q Now, this incident occurred at 109 Conner Drive,  
17 correct?

18 A I don't know what you call it.

19 Q Okay.

20 A All I know is they call it the trailer park.

21 Q Okay. Do you remember giving a statement to the  
22 police in this case, a written statement?

23 A Later on. Just a small, because they come in Tasha's  
24 house.

25 Q Okay. And you remember essentially writing down what

- 1 all happened that day.
- 2 A Yeah.
- 3 Q Okay. And do you remember -- do you know whether or  
4 not when you gave that statement you identified the address  
5 as 109 Conner Drive?
- 6 A I don't know the address.
- 7 Q Okay. Now, have you been back to the residence since  
8 that occurred that day, the incident occurred?
- 9 A I went back there one time to help her move out from  
10 down in there.
- 11 Q Okay. Now, I believe you stated it was foggy and  
12 rainy that day, correct?
- 13 A It was foggy and rainy.
- 14 Q Okay. Was it -- was it raining at the time?
- 15 A It wasn't really raining. It was foggy and rain.
- 16 Q Foggy and rain.
- 17 A Yeah.
- 18 Q Can you describe that to me? I'm from Kentucky, and  
19 I'm not familiar with that term. Do you mind describing  
20 that for me, please?
- 21 A You know, it's like little -- little foggy and rainy  
22 like dew.
- 23 Q Like mist?
- 24 A It wasn't really misting rain. It was fogging rain.
- 25 Q Okay. And did you drive your vehicle to the

- 1 residence?
- 2 A Uh-huh.
- 3 Q Okay. And what type of vehicle was that?
- 4 A It was S-10 pickup truck.
- 5 Q S-10 pickup truck. And this was -- what time of day
- 6 was this?
- 7 A It was kinda in the morning time.
- 8 Q In the morning time.
- 9 A Uh-huh.
- 10 Q And this was in December, wasn't it?
- 11 A Yeah.
- 12 Q Okay. Do you know -- did you have your windows up or
- 13 down in the truck?
- 14 A I had my windows up.
- 15 Q You had your windows up.
- 16 A Uh-huh.
- 17 Q Okay. And I believe you stated that Breezy -- I think
- 18 his name is Debris, correct?
- 19 A Yeah.
- 20 Q Okay. He was already outside on the porch at
- 21 Natasha's house, right?
- 22 A No. He wasn't on the porch. He was standing on the
- 23 ground on the -- on the passenger side where Martha Jean
- 24 was sitting with his arm leaning up against the truck like
- 25 this smoking a cigarette.

Dorothy Boyd  
Cross-examination by Mr. Campbell

1 Q Okay, okay.

2 A And this tall, slim guy come outta the front of that  
3 trailer, because I was sitting catty-corner and looking up  
4 that way. And I could hear him just as good. He said,  
5 "Hey, Breezy, come here."

6 Q Okay.

7 A And he just walked on up there and went about middle  
8 ways of the trailer. And I guess he hear'ed that guy come  
9 outta the back. So he jumped and looked around, and he saw  
10 him with the gun.

11 Q Okay. Do you know -- how long was the conversation  
12 between the -- this tall guy and Debris?

13 A Just a few minutes, no longer than he see'd Prince.

14 Q Okay. Just a -- just a few minutes, correct?

15 A Yeah.

16 Q Was Debris still talking to this guy when the alleged  
17 shooter came out of the apartment or came out of the  
18 trailer?

19 A We couldn't hear what he was saying to him, but I did  
20 hear him call him. And after he saw Prince with that gun,  
21 he turned around and took off a-running.

22 Q Okay. All right. Before the shooter came out of the  
23 trailer, okay, did the conversation between Debris and this  
24 gentleman end?

25 A I guess it did.

Dorothy Boyd  
Cross-examination by Mr. Campbell

1 Q Okay. Now, like I said, I believe -- I asked you a  
2 few minutes ago if you gave a statement to the police,  
3 correct?

4 A Uh-huh.

5 Q Do you remember telling the police that the gentleman  
6 who Debris was having a conversation with had walked off?

7 A I don't remember saying that.

8 Q Okay.

9 A Because he was still standing at the trailer.

10 Q Give me just one moment, please.

11 (Voluntary statement marked Defendant's Exhibit No.  
12 1.)

13 Q Ms. Boyd, I am going to show you what's previously  
14 marked as Defense Exhibit 1. Okay?

15 A Uh-huh.

16 Q Can you identify this for me, please? Take your time  
17 and read it. I just want to know if you can identify that  
18 for me.

19 A Come here and read the rest of this.

20 Q Yes, ma'am.

21 A It's real small. Read that.

22 Q At what point? I'm sorry.

23 A About there.

24 Q Okay. Would you like for me to read the entire  
25 statement to you?

Dorothy Boyd  
Cross-examination by Mr. Campbell

- 1 A Yeah.
- 2 Q Would you agree that that's your name at the top?
- 3 A Yes, sir.
- 4 MR. BARNETTE: Your Honor, if he would like to  
5 introduce it, I have no objection to that.
- 6 MR. CAMPBELL: I will introduce the statement, Your  
7 Honor.
- 8 THE COURT: Okay.
- 9 Q Ms. Boyd, and that's your signature at the bottom?
- 10 A Yeah, it is.
- 11 Q Okay. Now, the specific point I want to get to, Your  
12 Honor, or, Ms. Boyd, is you stated that Breezy started  
13 walking up the hill. I believe that's where you stated he  
14 went and talked to the guy, correct?
- 15 A Uh-huh.
- 16 Q And then you saw Breezy talking to the black guy.  
17 That's the tall individual, correct?
- 18 A Uh-huh.
- 19 Q And then you say the black guy walked off and Breezy  
20 was just standing there.
- 21 A I don't remember saying that.
- 22 Q Okay. What I want to show you is midway through this  
23 statement right here. Would you agree with me that that  
24 says the black guy walked off and Breezy was just standing  
25 there smoking a cigarette?

Dorothy Boyd  
Cross-examination by Mr. Campbell

1 A No. That didn't happen.

2 Q Okay. So you're saying this statement that you gave  
3 to the police on December the 16th of 2010 is wrong?

4 A He might have got that mixed up, because I don't  
5 remember saying that.

6 Q Okay. But you do --

7 A Because I know what I saw.

8 Q Okay. But you do admit that that's your signature at  
9 the bottom.

10 A Yeah, that's my signature.

11 Q Okay.

12 A And let me see. What is this girl's name comes down  
13 there with that? And her name is Ann Houey. Ain't that  
14 Ann Houey's daughter with that man?

15 Q And I just want to reiterate today that the man that  
16 that you saw shoot Debris Houey is not in the courtroom  
17 today.

18 A I don't know. I don't know whether that's him or not.  
19 He looked like he was bigger than that.

20 MR. CAMPBELL: No further questions, Your Honor.

21 A And that was my first time really being up close to  
22 him and seeing him all over.

23 I had been seeing that orange looking car going through  
24 town sometimes like when I be going through town, like I be  
25 going one way and he be going another way. And I would see

1 that orange looking car. And the most part I see'd was  
2 faded, but that day that was my first time seeing his whole  
3 body.

4 Q Is that after the incident you would see that orange  
5 looking car?

6 A Say that again.

7 Q Okay. You stated -- you just stated that you would  
8 see that orange looking car and you could see half his  
9 face, correct?

10 A I say I could see his face from -- from here back up.

11 Q Yes, ma'am.

12 A When he be's in his car.

13 Q What I'm asking is when you would see him was that  
14 after December the 16th of 2010.

15 A That was before he -- Breezy got shot.

16 Q That was before Breezy got shot.

17 A That's right.

18 Q Okay.

19 A But I never had -- never said anything to him or been  
20 close to him. Like -- like he be going that way and I be  
21 coming this way. And he be going that way. I be going  
22 another way.

23 Q Did you pull a silver handgun off Debris that day?

24 A No, sir. Breezy didn't have anything on him. The  
25 only thing he had was a cigarette in his hand.

Martha Houey  
Direct examination by Mr. Barnette

1 Q Do you know a Janet Lindsay?

2 A Janet Lindsay?

3 Q Yes, ma'am.

4 A Yeah, I know Janet Lindsay.

5 Q Did you ever tell Janet Lindsay you pulled a silver  
6 handgun off Debris?

7 A No, sir, uh-uh. I ain't talked to her about this.

8 MR. CAMPBELL: No further questions, Your Honor.

9 MR. BARNETTE: No further questions of the witness,  
10 Your Honor.

11 THE COURT: Thank you, Ms. Boyd. You may step down.

12 THE WITNESS: I don't know where he got that from.

13 MR. BARNETTE: Your Honor, the state would like to  
14 call Ms. Martha Houey, please.

15 MARTHA HOUEY, having been  
16 first duly sworn, testified as follows:

17 DIRECT EXAMINATION BY MR. BARNETTE

20 A Martha Jean Houey.

21 Q And where do you live at, ma'am?

22 A 349 Estelle Road in Gaffney.

23 Q And can you tell me --

25 minute. You might need to pull that microphone a little




