**APPELLANTS' RETURN TO RESPONDENT'S MOTION TO STRIKE AND FOR
LEAVE OF COURT TO ADD A CITATION TO APPELLANTS' BRIEF AND TO
AMEND APPELLANTS' DESIGNATION OF MATTER**


Respondent has moved to strike any reference to the loan application submitted by Defendants Brooks, Boyer and Osario contained in Appellants' Initial Brief. Respondents incorrectly allege that the loan application was never introduced in the circuit court. In fact, both

the loan application itself and the testimony of Mr. Warrick, the Respondent Bank's representative regarding the loan application, were submitted to the Circuit Court. The loan application appeared as Exhibit 1 of the Warrick deposition which was provided to the Circuit Court along with the entire Warrick Deposition and Exhibit packet on April 20, 2015 as a part of the summary judgment process.

It is true Appellants inadvertently omitted the citation to the Warrick testimony and the exhibit in their Initial Brief, but that does not change the fact that both the testimony and the exhibit were before the lower court. Appellants propose to solve the problem by amending the brief and designation of matter. Following the challenged line, "To make matters worse, the Rogue Directors disclosed on the face of their loan application their intent to use the proceeds from the mortgage loan to purchase property for a new church," there should have been a citation reading, "(Warrick Deposition, pgs. 17 – 19 and Exhibit 1)." Because of this scrivener's error, Appellants' Designation of Matter also inadvertently omitted Exhibit 1 and Pages 17 – 19 of the Warrick Deposition.

Appellant respectfully requests the Court **DENY** Respondent's Motion to Strike because the challenged material was part of the record before the lower court; and, **GRANT** Appellants leave of Court to correct the scrivener's errors. Appellants propose to add the missing citation to the Warrick Deposition and Exhibit to their brief, and to amend their Designation of Matter to include Pages 19 -21 of the Warrick Deposition and Exhibit 1 to the Warrick Deposition as shown on the attached Amended Designation of Matter.
