I am Dorothy Hampton-Amiley Staton. I am Presently residing at 7901 Farrow Road - this is the Overall address, I have no idea why they gave me the address of 220 Faison Drive because I have been receiving all my name or mail at 7901 Farrow Road, Columbia SC, 29203. But now they have made it so that I am using 220 Faison Drive, Columbia, SC, 29203.

I am a South Carolina State College Graduate of ~~class~~^{class} of 1970-1977-1979 I graduated ~~in~~^{and} Marched in 1980.

I have lived in Columbia Regional Care Hospital since 1990 and was (dismissed as the Court order will tell you) in 2001. I was sent to Northwood Residential Care in Charleston S.C. for one year. There I volunteered at Goodwill Industries for about 4 month working Monday through Friday from 8:00 AM til 12:00 AM. In hopes that they would hire me, But it didnt work out that way.

Please excuse my poor penmanship But I am writing with a Flex pen and it is very difficult to write with.

I have worked several jobs with Duke Power, IBM, Kelly ~~Smith~~ Dirl and Olsten Temporary Services and also Elite Temporary Services.

I was born in Orangeburg, SC 29115 I lived at the last address at 218 Dutton Street, I went to Wilkinson High School in Orangeburg, S.C. 29115. I have worked a number of jobs in North Carolina my last job or substantial job was at South Carolina State College where I held the job of Administrative Assistant under Dr. Sharp in the Foreign Language Department for 6 months.

I have been married to George Winston Smiley for five years we have one child Regena Victoria Adair her first name was Regena Victoria Smiley before she was married to Malcolm Adair, They reside in Killeen, Texas.

I then married Linwood Staton from Greenville, North Carolina. We ~~stayed~~ stayed together for about 5 years.

I returned to Orangeburg, SC 29115 where I set up housing at Glenwood Apartments. At that time I, after being under so much pressure + tension from my marriages I ^{had} have a breakdown

where I killed or ^{page 5} at least thought I killed
my sister, my second oldest sister rushed to
me at the Jail house on the second day of
my incarceration and asked me to sign ~~at~~
a power-of-Attorney and said please sign 'if
I don't have time for you to read it I have
to go somewhere,

I was the "Black" sheep of the family,
They treated me awfully called me names
that stuck with me for years. Called me
dumb constantly and degraded me. Now
they never hardly visit me or try to
get in touch with me, I must always
do all the getting ⁱⁿ touch with them.

They I must ~~some~~ say drove me insane
And both my husbands had part in it
too. They beat me almost senseless, They
never told me about the facts of life
or anything all I learned is from
reading books like love stories and
such. They never volunteered any information.
~~Even~~ Even when I got my divorce, from
my first husband they told me nothing
or refused to ask me what happened and
why was I getting a Divorce, my mother
did very little for me in training me
or instructing me and none of my
6 sisters and 4 brothers told me nothing,
worthwhile.

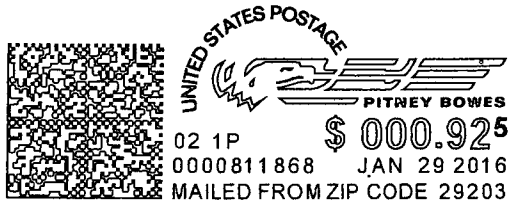
I have been at JustCare since 1990 and I never knew that I had been released because every time I tried to leave the Law would stop me and bring me back to the hospital. Bull street was my first place of incarceration, then after I left Charleston I went to MUSC where they transported me secretly to Columbia Regional Hospital at 7901 Farrow Road. To make a long story short, I think I have been had. They never gave me any money but on rare occasions, when I stayed at the residential Homes they only gave me \$45.00 for my care. I lived at Hopkins or Turning Point for about 2 months where I took an over dose because my sister refused to come and see me she came as far as Blue Johnson Road in Hopkins and turned around saying it was snowing too hard which I feel was a lie.

That's all I would like to say except my husband got custody of our 8 year old daughter + hid her from me.

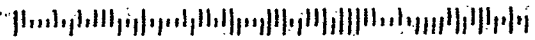
