MOTION TO STRIKE APPELLANT'S DESIGNATION OF MATTER

On December 11, 2015 and December 23, 2015, Appellant filed Designations of Matter with this Court. Appellant's Designations both reference Exhibits 1-4. These exhibits are attached to Appellant's Designation filed December 11, 2015. Exhibit 1 is a Step 1 Grievance Form signed by Appellant on 10/12/2014. Exhibit 2 is a Step 2 Grievance Form signed by Appellant on 10-17-14 and stamped "received" by the inmate grievance office on 10/21/14. Exhibit 3 is a copy of SCDC policy regarding the Interstate Corrections Compact. Exhibit 4 is a copy of a letter to Daniel Crooks (formerly a staff attorney in the SCDC General Counsel's Office) signed by Appellant on June 2, 2015.

None of the documents included in Appellant's Designation of Matter pertain to this particular appeal. This appeal is challenging the September 25, 2015 order of Administrative Law Judge S. Phillip Lenski, for ALC Docket Number 15-ALJ-04-0313-AP, grievance number MACD 0127-14. It appears that the documents referenced in Appellant's Designation of Matter

pertain to Appellant's previous appeal, Appellate Case Number 2015-000775, ALC Docket Number 15-ALC-04-0001-AP, which was challenging Judge Shirley C. Robinson's January 28, 2015 order denying Appellant's grievance number MACD 0106-14. This previous appeal was dismissed by this Court and was remitted on September 17, 2015.

In light of the foregoing, Respondent moves to strike Appellant's Designation of Matter and requests that this Court require Appellant to file a new, proper Designation within a reasonable period of time.
