

Ricky Blackwell. Counsel filed petition for writ of certiorari and accompanying appendix in the case of Supreme Ackbar v. State with the Supreme Court on December 11, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Tykeem May with the Court of Appeals on December 10, 2015. Counsel filed a petition for writ of certiorari to the Court of Appeals in the case of State v. Lamar Brown with the Supreme Court on November 30, 2015. Counsel filed the brief of appellant and designation of matter in the case of State v. Eric Owens with the Court of Appeals on November 25, 2015. Counsel filed the initial brief of respondent and designation of matter in the case of State v. Corey Williams with the Court of Appeals on November 19, 2015. Counsel had an oral argument in the case of State v. Zinah Jennings before the Court of Appeals on November 18, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by the consent below, counsel for the state graciously consents to or does not oppose this request.


