OUT OF TIME**

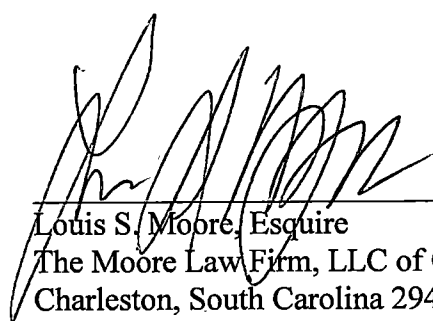

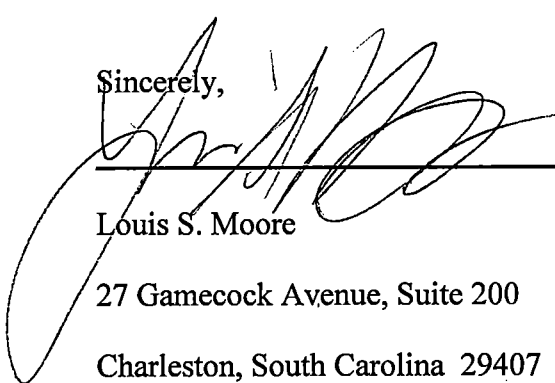

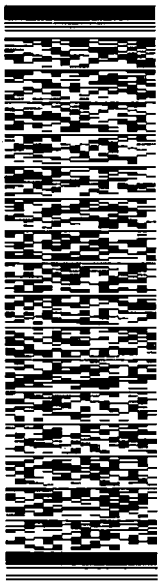
