1 A. I'm a full time analyst. First of all, I'm a
2 sworn law enforcement officer, so that's my first primary
3 duty, but I'm also an analyst within the digital evidence
4 unit. I do law enforcement training, receive the
5 training, and then I also provide the digital evidence
6 training to new hires within the department.

7 I also provide digital evidence training to
8 investigators and detectives within the department, and I
9 perform the analyzation and extraction when the digital
10 media comes into our unit.

11 Q. And can you explain to the jury how the services
12 of the DEU are requested, and can you kind of take us
13 through that process.

14 A. Yes, ma'am. Whenever an investigator, detective,
15 officer has a piece of digital media -- that could be a
16 laptop, desktop, cell phone, memory card, any kind of
17 electronic magnetic stored device -- when they need that
18 process analyzed or extracted from, they will take that
19 and put it into our CP evidence control room. At that
20 point, a request sheet and an authorization to do the
21 work is sent to us.

22 On that request sheet, basic information is filled
23 out, their name, information, contact information, what
24 kind of case it is, where it was seized, and what they

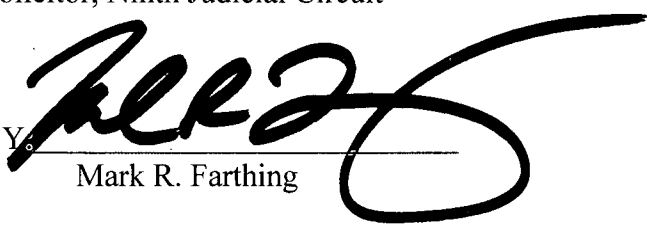
