**JOINT MOTION OF RESPONDENT/APPELLANT
AND RESPONDENT FOR EXTENSION OF TIME
TO FILE RESPONSE BRIEF**

Respondent/Appellant Branch Banking and Trust Company, Successor
in Merger to Branch Banking and Trust Company of SC, a/k/a BB&T
("BB&T"), together with Respondent James Edahl (collectively, "Movants"),
respectfully move for a 30-day extension of time in which to file their
Respondent's Initial Brief of Respondent/Appellant and Respondent and
designation of matter to the record on appeal. In support of this motion,
Movants would show as follows:

1. On January 14, 2016, BB&T filed and served its Appellant's Initial Brief of Respondent/Appellant and designation of matter. On the same day, Appellant/Respondent Skywaves I Corporation ("Skywaves") filed its Appellant's Initial Brief of Appellant/Respondent and designation of matter.

2. Movants' response briefs are due to be filed on or before Tuesday, February 16, 2016. Skywaves' Respondent's Initial Brief of Appellant/Respondent is also due on February 16, 2016.

3. By letter dated January 29, 2016, Skywaves requested an extension of 30 days for the filing of its Respondent's brief. Skywaves requested an extension to Monday, March 14, 2016. Although not noted in the letter, Movants consented to Skywaves' extension request.

4. In order to keep the briefing for these cross-appeals on the same schedule, Movants respectfully request that the time for filing their response brief be extended to match the filing date for Skywaves' response brief, whether that is March 14, 2016, or another date set by the Court.

5. Movants' counsel have consulted with counsel for Skywaves and are authorized to state that Skywaves consents to the relief requested in this motion.

WHEREFORE, Movants respectfully request that the deadline for filing their joint Respondents' Initial Brief of Respondent/Appellant and Respondent and designation of matter be extended to March 14, 2016, or to such other date as the Court may set for the filing of Skywaves' Respondent's


Initial Brief of Appellant/Respondent and designation of matter.



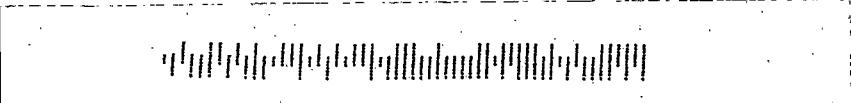
