THE APPELLANT MOVES THIS COURT for an order granting permission to file a Supplement Record on Appeal.


As a matter of background, the Appellant timely filed an appeal seeking relief from convictions and sentences rendered by the Beaufort County General Sessions court following a jury trial conducted in December, 2014. The parties exchanged initial briefs and designations of matter and filed these with the Court of Appeals. On February 1, 2016, the Appellate prepared, filed and served the appropriate number of copies of his final brief, final reply brief, and the record on appeal.

Unfortunately, undersigned counsel inadvertently omitted trial transcript pages requested by the Respondent in its designation of matter. 
