I just received a letter from you stating my case has been dismissed for failing to timely serve the notice of appeal. Rule 203 (b), SCACR, Time for Service (1) Appeals From the Court of Common Pleas. A notice of appeal shall be served on all respondents within thirty (30) days after receipt of written notice of entry of the order or judgment. When a timely motion for judgment n.o.v. (Rule 50 SCACP), motion to alter or amend the judgment (Rules 52 and 59 SCACP), or a motion for a new trial (Rule 59 SCACP) has been made, the time for appeal for all parties shall be stayed and shall run from receipt of written notice of entry of the order granting or denying such motion...

Rule 233, SCACR, Filing and Service (a) (2) By depositing the document in the U.S. Mail, properly addressed to the clerk, with sufficient postage attached. The date of filing shall be the date of delivery or the date of mailing.

Rule 234, SCACR, Time (a) Computation. In computing any period of time prescribed or allowed by these Rules, by order of court, or by any applicable statute, the day of the act, event, or default after which the designated period of time

begins to run is not to be included. The last day of the period so computed is to be included, unless it is a Saturday, Sunday or a state or federal holiday, in which event the period runs until the end of the next day which is neither a Saturday, Sunday nor such holiday...

I received written notice of the entry of the order denying my motion to alter or amend on Dec. 3, 2015, which was postmarked Dec. 01, 2015. (See the enclosed copy of the envelope) I sent my notice of appeal to the respondents through their counsel on Dec. 31, 2015, which was 28 days later. I then sent my notice of appeal to you and the Clerk of Richland County on Jan. 11, 2016, which was a Monday and was 11 days after as the 10th day fell on a Sunday. I have timely served my notice of appeal on all respondents and sent both you and Richland County Clerk in the time set by the above stated SCACR, therefore my case must be reinstated.
