**MOTION TO ALLOW FILING OF
SUPPLEMENTAL RECORD ON APPEAL**

Respondent (“the State”), through its undersigned counsel, would respectfully show unto the Court as follows:

I.

In its Designation of Matter, the State properly designated numerous pages from the trial transcript, including page 198, for inclusion in the Record on Appeal. Thereafter, on November 19, 2015, the Record on Appeal was served on the State, and it was later filed with the Court in December of 2015. However, the Record on Appeal as served and filed inadvertently did not include page 198 from the trial transcript.

II.

Because properly designated matter was inadvertently omitted from the Record on Appeal, the State believes it is necessary to file a Supplemental Record on Appeal containing the

inadvertently omitted matter. See Rule 210(c), SCACR (“The Record on Appeal shall include all matter designated to be included by any party under Rule 209[.]”). WHEREFORE, Respondent prays that this Court will allow the State to file a Supplemental Record on Appeal; accept the filing of the State’s Supplemental Record on Appeal; and for such other and further relief as the Court may deem just and proper.


