Appellant Terry Douglas Campbell has filed a motion to reinstate his appeal, which was administratively dismissed by the Court for Appellant's failure to timely serve his notice of appeal pursuant to Rule 203, SCACR.


According to the records of undersigned counsel for Respondents, Appellant's Notice of Appeal was received by undersigned's office on January 7,

2016 bearing a postmark of January 2, 2016, a copy of which is attached. Based on this postmark, it appears that Respondents were timely served with the Notice of Appeal. Therefore, Respondents do not oppose Appellant's Motion to Reinstate on timeliness grounds.<sup>1</sup>

However, Respondents do oppose permitting Appellant to proceed without the payment of filing fees as none of the factors for waiving filing fees in either Rule 203(d) or 240(d), SCACR, apply to this case.

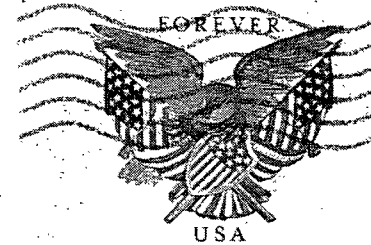



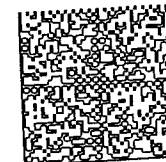
