1 It does not establish anything. Any person who is
2 accused of a crime that has to be tried in this Court,
3 in the Circuit Court, has to be brought here by way of
4 a document called an Indictment. That Indictment sets
5 forth the charge. It simply serves as a charging
6 paper. It puts the person accused of a crime on
7 notice as to what the State claims they have
8 committed. But it is not proof of anything and it
9 doesn't establish anything.

10 The State has the burden of proving a person's
11 guilt that is alleged in an Indictment before a jury
12 to select for that purpose, and they have the burden
13 of proving that person guilty beyond a reasonable
14 doubt. But in this case that has been brought and for
15 which some of you will be selected is the State versus
16 Julia Bright Phillips. Miss Phillips has been accused
17 by the State of having committed the crime of murder.
18 The State alleges that that occurred back on or about
19 February the 4th of 2010 and by way of this Indictment
20 the State alleges that Julia Bright Phillips did here
21 in York County on or about that date while acting in
22 an accomplice capacity with a principle offender who
23 identity is unknown, did unlawfully and with malice
24 aforethought kill one Melvin Roberts by means of
25 strangulation and that Mr. Roberts died as a proximate

1 result of those actions. And they alleged that the
2 killing occurred at the residence of Melvin Roberts
3 which is locate at 214 Robert's Avenue in York, South
4 Carolina.

5 Now, as to those allegations, and as to the charge
6 set forth in the Indictment the defendant has entered
7 a plea of not guilty and the plea of not guilty places
8 upon the State the burden of establishing the
9 allegations that they have made by way of this
10 Indictment. The burden of proving each of the
11 essential elements of the crime that they have alleged
12 against the defendant, and therefore the burden is
13 upon the State to establish the defendant's guilt to
14 the satisfaction of twelve jurors beyond a reasonable
15 doubt before any verdict of guilt could be returned.
16 So we are going to be selecting the twelve of you as
17 primary jurors. There will also be two additional
18 jurors selected to serve as alternate.

19 The function of an alternate is to simply take the
20 place of one of the original twelve jurors if one of
21 those jurors becomes ill or for some reason can not
22 continue to serve. So we will be selecting fourteen
23 of you to serve as jurors in the case. By way of your
24 participation you will be called upon to simply listen
25 to testimony that will be elicited from the witness

1 MS. HODGE: None from the State, Your Honor.

2 THE COURT: From the defendant?

3 MR. FREDERICK: No, sir.

4 THE COURT: All right. We will be at ease while
5 the jury continues to deliberate.

6 THE COURT: I am told the jury has reached a
7 decision. Are we ready to proceed?

8 MS. HODGE: The State is the ready.

9 MR. FREDERICK: Yes.

10 THE COURT: Bring them in please.

11 (WHEREUPON, jury enters the courtroom at 6:14.)

12 THE COURT: Madame forelady have you and your
13 fellow jurors reached a unanimous decision?

14 THE FOREPERSON: Yes, Your Honor.

15 THE COURT: Have you reflected that decision on
16 the back of the indictment as to the verdict?

17 THE FOREPERSON: Yes, sir.

18 THE COURT: And did you sign your name as
19 Foreperson?

20 THE FOREPERSON: Yes, sir.

21 THE COURT: If you please hand that verdict form up
22 by way of the bailiff?

23 You may publish the verdict.

24 THE CLERK: Indictment 2011-GS-46-1851 the State
25 versus Julia Bright Phillips, Indictment for murder,

1 verdict guilty. Signed by the foreperson. Dated
2 today's date.

3 Ladies and gentlemen is that your verdict so say
4 you all by raising your right hand. Let the record
5 show all the jurors have raised their hands.

6 THE COURT: Does the defendant wish to have the
7 jury polled.

8 MR. FREDERICK: Yes, sir.

9 THE COURT: All right. Poll the jury please
10 ma'am.

11 THE CLERK: Ladies and gentlemen man of the jury
12 please stand and as your name is called after I speak
13 to you you may sit. Everybody please stand.

14 Jury number 137, is this your verdict?

15 THE JUROR: Yes, ma'am.

2 THE COURT: All right. Thank you, ma'am.

3 THE DEFENDANT: Your welcome.

4 MR. FREDERICK: That is all judge.

5 THE COURT: Okay. Thank you.

6 All right. On Indictment 2011-GS-46-1851, an
7 Indictment for murder, wherein you have been found
8 guilty by a jury for that offense, the sentence of the
9 Court is you be Julia Bright Phillips be confined to
10 the South Carolina Department of Corrections for a
11 period of your natural life.

12 Miss Phillips, you have the right to appeal the
13 verdict of the jury and the sentence of the Court.
14 You must file a notice of your intention to appeal
15 those decisions within ten days of today's date. Mr.
16 Frederick I am sure will advise you accordingly.

17 THE DEFENDANT: Thank you. What do I do know?

18 THE COURT: Go with the sheriff.

19 THE DEFENDANT: Okay.

20 MS. HODGE: Thank you, Your Honor.


