

UNCONSTITUTIONAL SO CALLED CONVICTIONS [SIC]. OH WELL,

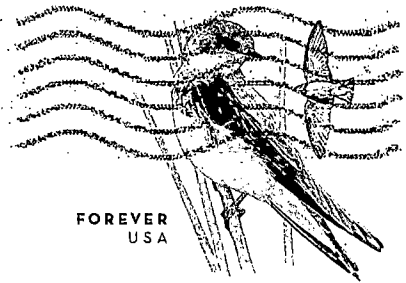
JUST TO ADVISE YOU, I HAVE ATTEMPTED ALL DAY, TO FIND

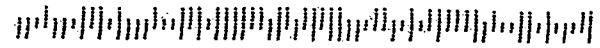
