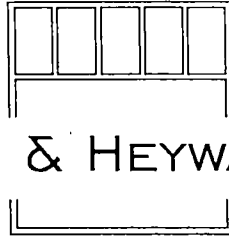

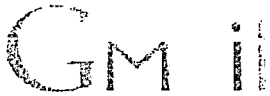
Dear Mr. Reeser,
