

AMENDED NOTICE OF APPEAL

Lorenzo Ragin appeals his probation revocation and sentence in this case. The sentence was imposed by the Honorable Howard P. King on February 10, 2016 in Sumter County.

The Defendant was originally sentenced by the Honorable R. Ferrell. Cothran in Clarendon County on October 13, 2014 to 3 years suspended to 90 days followed by 1 year probation. Subsequently, the probation was transferred to Richland County. The arrest warrant for violation of probation was issued in Richland County on September 28, 2015. On February 10, 2016, in Sumter County, during the plea to charges on indictments 2016GS430068-69, the Honorable Howard P. King found the Defendant in willful violation of probation, revoked suspended sentence and required the Defendant to serve 2 years and 9 months, the remainder of original sentence.




