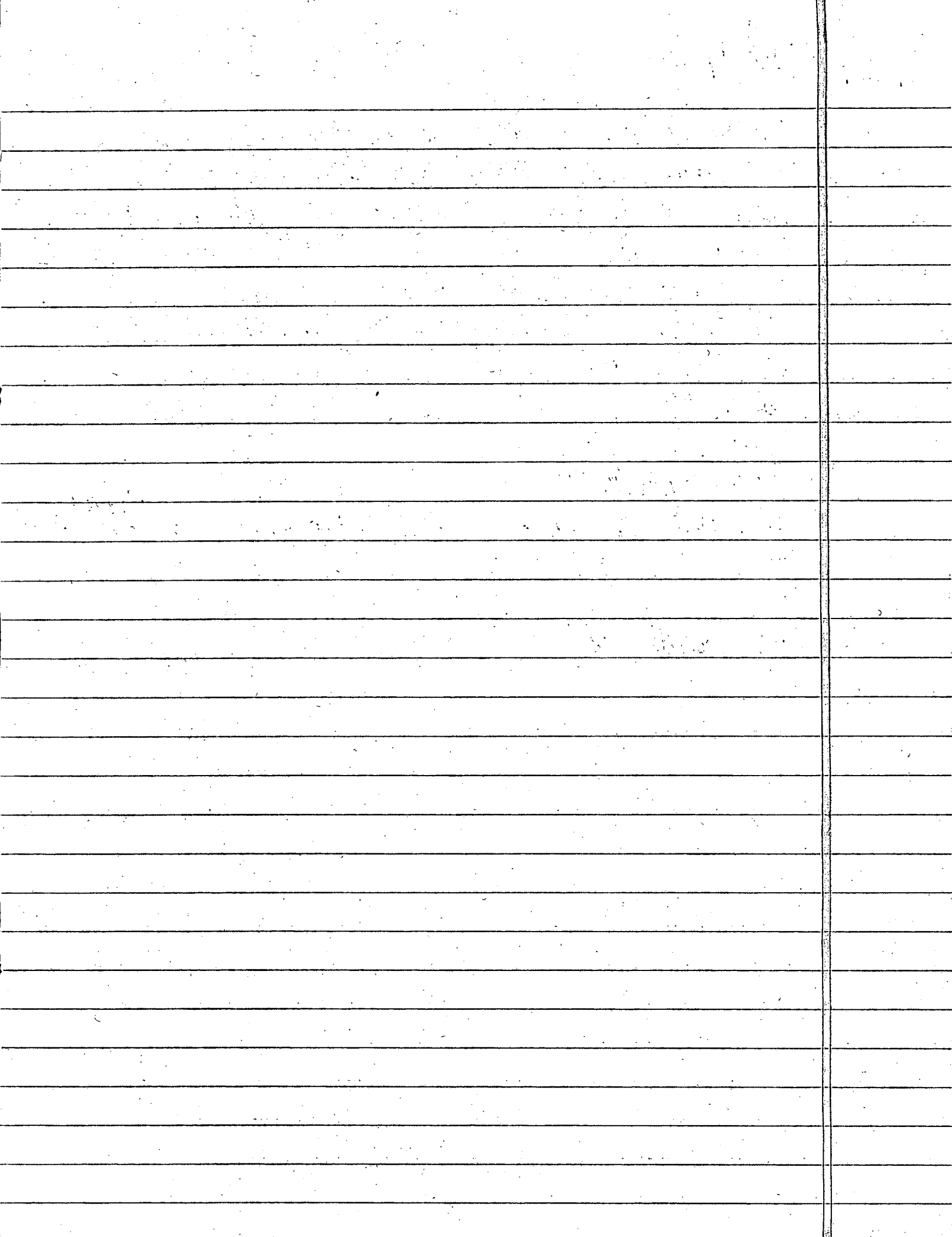

Pt. said that if he left ED he would fear that "I would be dead or somebody else would be." Pt. said that from talking to his friends, "I just feel like someone wants to kill me."
