**APPELLANT'S MOTION FOR EXTENSION**

Appellant Laura Weekley Segel, individually and as Personal Representative of the  
Estate Of William James Weekley, Deceased, moves this Court for permission to file her Proof  
of Service on the Record on Appeal outside of the filing deadlines set by Rule 210, SCACR.  
Rule 210(a), SCACR, requires the appellant to serve a copy of the Record on Appeal on each  
party who has served a brief within thirty (30) days after service of the last brief. Rule 210(a),  
SCACR. The proof of service of the Record on Appeal shall then be immediately filed with the  
Clerk of the Appellate Court. *Id.*

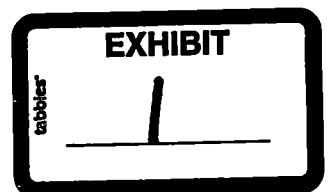


