Counsel filed the petition for writ of certiorari and accompanying appendix and the brief of appellant pursuant to White v. State in the case of Robert S. Horton v. State in this Court on January 8, 2016. Counsel filed the petition for an order to reconstruct the record of appellant's trial transcript, or, in the alternative, an order setting aside his convictions and ordering a new trial in the case of State v. Ivory Blackshire in the Court of Appeals on January 4, 2016. Counsel filed the Anders brief of Appellant and Record on Appeal in the case of State v. Roemain Jamil Brunson in the Court of Appeals on December 29, 2015.


3. This request is made in good faith, and not for purposes of delay.

4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.




