Dear Manager Allen:

The purpose of this letter is letting you know that according to Clerk of Court of Greenville County on January 25, 2016 date of hearing presided by Honorable D. Garrison Hill the Court Reporter in charge was Hollie M. Jenkins.

On January 29, 2016, an arraignment between at the time Plaintiff Zulveta and the Clerk of Court of Greenville County was made in order to obtain the Transcript of Case No.: 2015CP2305171. Afterwards, Clerk of Court of Greenville County did not honor the arraignment.

Same date on January 29, 2016 Plaintiff-Appellant Zulveta forwarded a letter with another one enclosed requesting from Court Reporter Jenkins an arraignments pertaining to: Ordering the Transcript (SEE EXHIBITS "A", and "B"). To this date Court Reporter Hollie M. Jenkins hasn't response request for Court Transcript.

As result, out of Court Reporter Hollie M. Jenkins's intentional and unlawful behavior against a party to a Civil Proceeding The South Carolina Honorable Court of Appeals has denied Plaintiff Zulveta his course of action in this appeal case. In addition, Court Reporter's Hollie's actions forced Plaintiff-Appellant Zulveta into take a different course of action requestingThe Court of Appeals for a Stay of Proceedings that it was not intended to be there.

Therefore, Plaintiff-Appellant Zulveta expects a complete, understandable, readable, with full complete spoken sentences, professional transcript, etc., upon its availability. Otherwise, as Plaintiff-Zulveta on prior occasion made this Honorable Court of appeals aware: "There should be good reason for Eyebrows and Red Flags be raised by Court Reporter's Management Team". If that occasion arisen, it (Transcript) should be held Incompetent to Stand at Trial. Charter Communications, LLC., case tossed.

Court Reporter Jenkins she doesn't want to be found. Greenville County Court has its own reasons making the Transcript unreachable to Plaintiff-Appellant Zulveta.

In addition, Plaintiff-Appellant Zulveta doesn't understand why in order to process anything related to Proceed in Forma Pauperis he has to pay a fee. 
