

A transcript will not be necessary, as this case was resolved on cross motions for summary judgment, without any evidentiary hearing or trial.

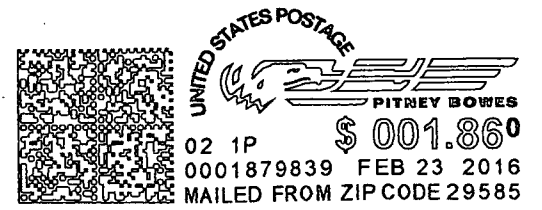
