That on October 4, 2014, at or around 12:15 am, the Defendant went to the Victim's place of residence unannounced and he was invited inside the residence to visit. Shortly after arriving, the Defendant began to physically assault the victim by striking her in the face and put a belt around her neck strangling her to the point of losing consciousness. The Defendant then tied the victim's hands behind her back using some sort of twine and attached another section of twine around her neck causing the loop around the victim's neck to get tighter as she moved her hands. The victim was left restrained for over an hour during which time the Defendant repeatedly told her that she would not leave her residence alive. The Defendant also removed an oyster knife from his waist area and began to poke the victim in her eyes before untying her.
