

Counsel filed the initial brief of appellant and designation of matter in the case of State v. David Hayes in the Court of Appeals on January 29, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Brian M. Curtis v. State in this Court on January 20, 2016. Counsel filed the Anders brief of appellant and designation of matter along with the Record on Appeal in the case of State v. James L. Singleton in the Court of Appeals on January 13, 2016. Counsel filed petition for rehearing in the case of State v. Damian Anderson in the Court of Appeals on January 7, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Frank Beckham v. State in this Court on January 7, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Derrick Prescott v. State in this Court on January 6, 2016.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


