The undersigned counsel would respectfully request a **final** thirty-day extension, until **April 4, 2016** in which to file the petition for writ of certiorari and appendix in the above-referenced case. In support of this motion, counsel would respectfully show the Court the following exigent circumstances:

1. The petition for writ of certiorari and appendix in this case are due to be served and filed today, having been extended by two prior orders of this Court.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Michael Robinson v. State in this Court on January 19, 2016. Counsel filed the Anders brief of Appellant and Record on Appeal in the case of State v. Jim Edward Feagin in the Court of Appeals on January 14, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix and the brief of appellant pursuant to White v. State in the case of Robert S. Horton v. State in this Court on January 8, 2016. Counsel filed the petition for an order to reconstruct the record of appellant's trial transcript, or, in the alternative, an order setting aside his convictions and ordering a new trial in the case of State v. Ivory Blackshire in the Court of Appeals on January 4, 2016.


3. This request is made in good faith, and not for purposes of delay.

4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.




