DEAR, Supreme Court of South Carolina

South Carolina does not recognize the offence of attempted murder, as conduct which would be included therein is adequately covered by offenses of assault and battery with intent to kill (ABIK) and assault with intent to kill (AIK), state v. Sutton cite as 532 S.E.2d 283 (S.C. 2000)

With that being said South Carolina is holding me on attempted murder, and by law should have been switched out with a lesser included charge such as ABIK or AIK, now the result lies in the hand of law abiding personell, such as a Supreme justice or the attorney that will present this case to the Court, but I also want to strike as unconstitutional the S.C. 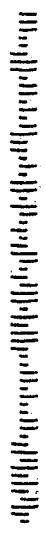

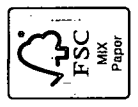
