
**RESPONDENT OAK POINTE HOMEOWNERS' ASSOCIATION, INC.'S MOTION FOR



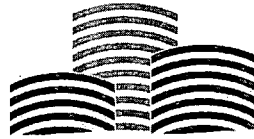
