NOTICE OF APPEAL

Patterson Construction, Inc., appeals the decision of the Full Commission dated February 23, 2016. Appellant received a copy of this decision on February 23, 2016. The issues on appeal are:

1. Whether the Commission erred in finding Adrian Salgado was on his normal work route, when he was involved in the May 4, 2015 motor vehicle accident.
2. Whether the Commission erred in finding Adrian Salgado had not deviated from his work route, when he was involved in the May 4, 2015 motor vehicle accident.
3. Whether the Commission erred in finding Adrian Salgado was in the course and scope of his employment, when he was involved in the May 4, 2015 motor vehicle accident.
4. Whether the Commission erred in finding Adrian Salgado is entitled to temporary benefits from May 4, 2015 and continuing.
5. Whether the Commissioner erred in finding it had jurisdiction over Adrian Salgado's alleged May 4, 2015 motor vehicle accident.

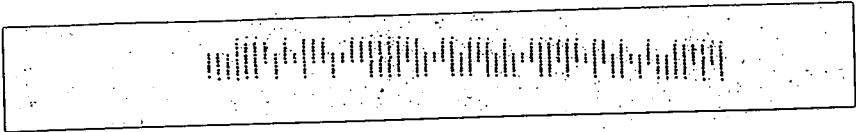

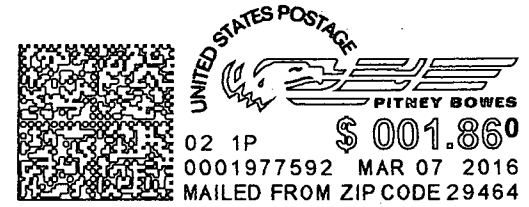
